


**SANTA YNEZ RIVER WATER CONSERVATION DISTRICT

**2025/2026 FISCAL YEAR APPROPRIATION LIMITATION CALCULATION**

Santa Barbara County population change and California per capita personal income change data published by the State of California Department of Finance (May 2025) are used in computing the 2025/2026 Appropriation Limitation Calculation as follows:

2024/25 Appropriation Limit	\$2,481,499
Per Capita Personal Income Percentage Change over Prior Year	6.44 percent
Population Change over Prior Year Santa Barbara County	0.63 percent
Per Capita converted to a ratio:	$\frac{6.44 + 100}{100} = 1.0644$
Population converted to a ratio:	$\frac{0.63 + 100}{100} = 1.0063$
CPI Factor	1.0644
Population Factor	1.0063
CPI Factor X Population Factor	1.0711
<b>1.0711 x \$2,481,499 =</b>	<b><u>\$2,657,934</u></b>
